

NESTLÉ PURINA PETCARE – FRISKIES CONVENTION SWEEPSTAKES
Official Rules

NO PURCHASE OR PAYMENT NECESSARY. A PURCHASE WILL NOT IMPROVE YOUR CHANCES OF WINNING. VOID WHERE PROHIBITED BY LAW.

BY ENTERING THE SWEEPSTAKES EACH ENTRANT (OR THEIR PARENT/LEGAL GUARDIAN) AGREES TO THESE OFFICIAL RULES.

1. **Eligibility:** The Nestlé Purina Petcare – Friskies Convention Sweepstakes (the "Sweepstakes") is open only to legal residents of the 50 United States and District of Columbia who are 18 years or older (or 19 if resident of AL or NE). Void where prohibited by law. No purchase necessary to enter the Sweepstakes. 2. **Sweepstakes Period:** The Sweepstakes starts at 12:00:00 AM Central Time ("CT") on August 20, 2026, and ends at 11:59:59 PM CT on September 26, 2026 ("Sweepstakes Period").
3. **How to Enter.** To enter, download the free myPurina mobile app (the "App") available through the app store on your mobile device and register on the App. Once registered on the App, eligible entrants can log into the App using their Purina Rewards member log-in, open the Rewards Catalog to find and add the "Nestle Purina Pet Care "Friskies Convention" Sweepstakes Entry item to their Rewards Cart and complete the checkout process to receive one (1) entry into the Sweepstakes random drawing. Limit one (1) entry per person during the entire Sweepstakes Period. All entries must be submitted by 11:59:59 PM CT on September 26, 2026, to be eligible for the random drawing. Sponsor is not responsible for any technical glitches associated with the entry process.
4. **Winner Selection and Notification:** Six (6) Grand Prize winners will be selected via a random drawing to be held by Administrator on or about September 29, 2026. Each potential winner will be notified by Administrator via email notifying the individual they are a potential winner, to be sent to the email address associated with the potential winner's App registration on or about the day of the random drawing (each a "Winner Notification"). Each potential winner must respond within **72 hours** from Administrator sending the Winner Notification email to the potential winner in order for Administrator to verify a potential winner's contact information and eligibility. In the event a potential winner fails to respond to the Winner Notification within **72 hours**, that potential winner forfeits their right to be the Grand Prize winner and their right to receive the Grand Prize, and an alternate winner will be selected, time permitting, at Sponsor's sole discretion.
