

**NESTLE PURINA PETCARE “YEAR OF FREE FANCY FEAST 3OZ. WET CAT FOOD”
SWEEPSTAKES
Official Rules**

- 1. Eligibility:** The Nestlé Purina PetCare “Year of Free Fancy Feast 3oz. Wet Cat Food” Sweepstakes (the “Sweepstakes”) is open only to legal residents of the 50 United States and District of Columbia who are 18 years or older (or 19 if resident of AL or NE) and are members of the Purina Rewards loyalty program at the time of entry. THIS PROMOTION IS NOT OPEN TO THE GENERAL PUBLIC. Void where prohibited by law. No purchase necessary to enter the Sweepstakes. Employees of Nestlé Purina PetCare Company, 1 Checkerboard Square, St. Louis, MO 63164 (the “Sponsor”), Brandmovers, Inc., 1320 Ellsworth Ind Blvd, Ste A1000, Atlanta, GA 30318 (the “Administrator”) (collectively with Sponsor the “Released Parties”), and any of their respective affiliates, subsidiaries, advertising agencies, or any other company or individual involved with the design, production execution or distribution of the Sweepstakes and their immediate family (spouse, parents and step-parents, siblings and step-siblings, and children and step-children) and household members of each such employee are not eligible to enter or win. The Sweepstakes is subject to all applicable federal, state and local laws and regulations. Participation constitutes entrant's full and unconditional agreement to these Official Rules and Sponsor's decisions, which are final and binding in all matters related to the Sweepstakes. Winning a prize is contingent upon fulfilling all requirements set forth herein.
- 2. Sweepstakes Period:** The Sweepstakes starts at 08:00:01 AM CT on June 1, 2026 and ends at 08:00:01 AM CT on July 1, 2026 (“Sweepstakes Period”).
- 3. How to Enter.** To enter the Sweepstakes, Open your myPurina app (on Apple or Android) and log in using your Purina Rewards member log-in (“Rewards Account”). Once logged in, open the Rewards Catalog and add the Free Year of Fancy Feast Sweepstakes Entry item to your Rewards Cart, and complete the checkout process to receive one (1) entry into the Sweepstakes random drawing.

Alternatively, you may email customer service at www.purina.com/contactus and provide your full name, address, and the email associated with your Purina rewards account to receive one (1) entry into the Sweepstakes.

All entries must be submitted by 8:00:01AM CT on July 1, 2026, to be eligible for the Sweepstakes random drawing. Sponsor is not responsible for any technical issues relating to the entry.

- 4. Winner Selection and Notification:** One (1) winner will be randomly selected from all eligible entries, to be conducted by Administrator on or around July 6, 2026 from among all eligible entries received. The potential winner will be notified by Administrator or Sponsor via email to

the email address associated with the potential winner's Rewards Account to be sent on or about the day of the random drawing ("Notification").

Potential winner must respond via email, within **144 hours** from the Notification sent to their email address or prize will be forfeited and awarded to an alternate winner. Odds of winning depend on the total number of entries received.

- 5. Prize and Approximate Retail Values ("ARVs"):** One (1) Grand Prize : 61 coupons for FREE (up to \$26.99) one (1) 24 ct package (3oz cans) of Fancy Feast(r) Wet Cat Food; Max ARV: \$1646.39.

Prizes are non-transferable, and not substitutable and not redeemable for cash. Participation Conditions/Release/Consent to use Likeness:** By participating, each participant agrees to: (a) comply with and be bound by these Official Rules and the decisions of the Sponsor which are binding and final in all matters relating to this Sweepstakes; (b) release and hold harmless the Released Parties from and against any and all claims, expenses, and liability, including, but not limited to, negligence and damages of any kind to persons and property, including, but not limited to, invasion of privacy (under appropriation, intrusion, public disclosure of private facts, false light in the public eye or other legal theory), defamation, slander, libel, violation of right of publicity, infringement of trademark, copyright or other intellectual property rights, property damage, or death or personal injury arising out of or relating to a participant's participation in this Sweepstakes, and acceptance or use or misuse of prize; (c) indemnify, defend and hold harmless the Released Parties from and against any and all claims, expenses, and liabilities (including reasonable attorney's fees) arising out of or relating to an entrant's participation in the Sweepstakes and/or entrant's acceptance, use or

misuse of prize; and (d) allow Sponsor's use for promotional purposes of his/her likeness, voice and/or address (city/state) without any additional compensation.

General Conditions:** Sponsor reserves the right to cancel, suspend and/or modify the Sweepstakes, or any part of it, for any reason whatsoever, including, without limitation, fire, flood, natural or man-made pandemic or epidemic of health or other means, earthquake, explosion, labor dispute or strike, act of God or public enemy, satellite or equipment failure, riot or civil disturbance, terrorist threat or activity, war (declared or undeclared) or any federal state or local government law, order, or regulation, public health crisis, order of any court or jurisdiction or if any fraud, technical failures or any other factor beyond Sponsor's reasonable control impairs the integrity or proper functioning of the Sweepstakes, as determined by Sponsor in its sole discretion. Sponsor reserves the right, in its sole discretion, to disqualify any individual it finds to be tampering with the participation process or the operation of the Sweepstakes or to be acting in violation of these Official Rules or any other Sweepstakes or in an unsportsmanlike or disruptive manner. Any attempt by any person to deliberately undermine the legitimate operation of the Sweepstakes may be a violation of criminal and civil law, and, should such an attempt be made, Sponsor reserves the right to seek damages from any such person to the fullest extent permitted by law. Only the type and quantity of prize described in these Official Rules will be awarded. The invalidity or unenforceability of any provision of these rules shall not affect the validity or enforceability of any other provision. In the event that any provision is determined to be invalid or otherwise unenforceable or illegal, these rules shall otherwise remain in effect and shall be construed in accordance with their terms as if the invalid or illegal provision were not contained herein. Sponsor's failure to enforce any term of these Official Rules shall not constitute a waiver of that provision.
- 9. Limitations of Liability:** The Released Parties as set forth above are not responsible for: (1) any incorrect or inaccurate information, whether caused by entrants, printing errors or by any of the equipment or programming associated with or utilized in the Sweepstakes; (2) technical failures of any kind, including, but not limited, to malfunctions, interruptions or disconnections in phone lines or network hardware or software; (3) unauthorized human intervention in any part of the participation process or the Sweepstakes; (4) technical or human error which may occur in the administration of the Sweepstakes or the processing of phone calls; or (5) any injury or damage to persons or property which may be caused, directly or indirectly, in whole or in part, from entrant's participation in the Sweepstakes or receipt or use or misuse of any Prize.

Disputes/Governing Law:** Entrant agrees that: any and all disputes, claims and causes of action arising out of or connected with this Sweepstakes, other than those concerning the administration of the Sweepstakes or the determination of Winner or for any disputes arising from the loss or injury from the participation in a Prize, shall be resolved individually, without resort to any form of class action; (ii) any disputes arising out of these Official Rules (except for any disputes arising from the loss or injury from the use of Prizes) shall be submitted to final, binding arbitration conducted in Missouri under the Arbitration Rules and Procedures of the Judicial Arbitration and Mediation Services Inc. before a single, neutral arbitrator who is a former or retired Missouri state or federal court judge with experience in entertainment

matters who shall follow Missouri law and the Federal Rules of Evidence and have no authority to award punitive damages. Either party may enforce a final arbitration award in any court of competent jurisdiction in Missouri including an award of costs, fees and expenses incurred in enforcing the award. Notwithstanding the foregoing, Released Parties shall be entitled to seek injunctive relief (unless otherwise precluded by any other provision of these Official Rules) in the state and federal courts of Missouri. Any dispute or portion thereof, or any claim for a particular form of relief (not otherwise precluded by any other provision of these Official Rules), that may not be arbitrated pursuant to applicable state or federal law may be heard only in a court of competent jurisdiction in Missouri; (iii) any and all claims, judgments and awards shall be limited to actual out-of-pocket costs incurred, including costs associated with entering this Sweepstakes, but in no event attorneys' fees; and (iv) under no circumstances will entrant be permitted to obtain awards for, and entrant hereby waives all rights to claim punitive, incidental and consequential damages and any other damages, other than for actual out-of-pocket expenses, and any and all rights to have damages multiplied or otherwise increased.
