

**Purina Petcare “Friskies Giveaway”  
Terms and Conditions**

**THIS IS A FIRST-COME, FIRST-SERVED GIVEAWAY. NO PURCHASE IS NECESSARY TO PARTICIPATE.**

**1. Giveaway Overview.** This is a first-come, first-served promotion where Sponsor will give away one **(1) FREE \$10.00 Coupon Valid for one (1) Friskies 12ct. Package** (the “FREE Product coupon”) to the first 5,000 eligible myPurina App Rewards members who successfully submit a request for the FREE Product coupon during any Giveaway Window (defined in Section 3 below). **No more than 62,500 FREE Products** will be given away during the entire Giveaway Period (defined in Section 3 below).

**2. Eligibility.** To be eligible to receive a FREE Product coupon, you must be a legal residents of the 50 United States or the District of Columbia, be at least 18 years of age or older (or 19 years of age or older if a resident of AL or NE) and be a current registered myPurina app (“App”) rewards member. To become an App member for free, visit mypurina.com or find the App in the app store on your mobile device. Void where prohibited. Employees of Nestlé USA, Inc (“Sponsor”), Brandmovers, Inc. (“Fulfillment Agency”) and/or any of their respective affiliates, subsidiaries, advertising agencies, or any other company or individual involved with the design, production execution or distribution of the FREE Product coupon or this Giveaway (collectively with Sponsor, the “Giveaway Entities”) and their immediate family (spouse, parents and step-parents, siblings and step-siblings, and children and step-children) and household members of each such employee are not eligible to participate or receive a FREE Product. The Giveaway is subject to all applicable federal, state, and local laws and regulations. Participation constitutes participant’s full and unconditional agreement to these Terms and Conditions and Sponsor’s decisions, which are final and binding in all matters related to the Giveaway.

**3. Giveaway Dates.** The Giveaway begins at 12:00:00 AM Eastern Time (“ET”) on May 31, 2026, and ends at 11:59:59 PM ET on July 19, 2026, but it will only be offered and available beginning any time the US Men’s soccer team scores a goal during any of the matches within the Giveaway Period and the goal is officially counted as a goal in the match and ending thirty (30) minutes after that goal is scored and counted as an official goal, or, when 5,000 Requests are received, whichever occurs sooner (each, a “Giveaway Window” or collectively, the “Giveaway Period”). Sponsor’s clock is the official timekeeper of this promotion. In the event there are any remaining FREE Product coupons after the Giveaway Period ends, Sponsor will offer any remaining FREE Product coupons to eligible rewards members on a first-come, first-served basis until all 5,000 FREE Product coupons are given out.

**4. How To Request a FREE Product coupon:** During any Giveaway Window, eligible participants may open their App to access the FREE Product coupon within the myPurina Rewards Catalog (each, a “Request”). Requests must be submitted within the applicable 30-minute Giveaway Window described in Rule #3 above, and participants must be among the first 5,000 eligible Requests received during that Giveaway Window in order to receive a FREE Product coupon.

Participants may submit more than one Request during the Giveaway Period; however, there is a limit of one (1) FREE Product coupon per person and per household during the entire Giveaway Period. Once a participant or household has received a FREE Product coupon, any subsequent Requests submitted by that participant or household will not be eligible to receive an additional FREE Product coupon.

In the event of a dispute regarding the identity of the person submitting a Request, the authorized account holder of said e-mail account associated with that reward members App account at the time of the Request was submitted. “Authorized account holder” is defined as the natural person who is assigned an e-mail address by an Internet access provider, on-line service provider or other organization which is responsible for

assigning e-mail addresses or the domain associated with the submitted e-mail address. The participant may be required to provide evidence that the participant is the authorized account holder.

Sponsor is not responsible for lost, late, incomplete, invalid, or technical glitches associated with the Request process. Any attempt to submit more than one (1) Request by using multiple/different identities, or any other methods, may disqualify that individual from receiving the FREE Product coupon, at the sole discretion of Sponsor. **5. Receiving Your FREE Product coupon.** Upon Sponsor's receipt of a successful and compliant Request, the Sponsor will mail the FREE Product coupon to each recipient, to be sent to the address associated with the recipient's myPurina App account. Allow 6 to 8 weeks for the mailing of any FREE Product coupon.

**7. Participation Conditions and Release.** By submitting a Request, each participant agrees to: (a) comply with and be bound by these Terms and Conditions and the decisions of the Sponsor which are binding and final in all matters relating to this Giveaway; (b) release and hold harmless the Giveaway Entities from and against any and all claims, expenses, and liability, including but not limited to negligence and damages of any kind to persons and property, including but not limited to invasion of privacy (under appropriation, intrusion, public disclosure of private facts, false light in the public eye or other legal theory), defamation, slander, libel, violation of right of publicity, infringement of trademark, copyright or other intellectual property rights, property damage, or death or personal injury arising out of or relating to a Request, participation in the Giveaway, acceptance or use or misuse of the FREE Product coupon; and (c) indemnify, defend and hold harmless the Giveaway Entities from and against any and all claims, expenses, and liabilities (including, without limitation, reasonable attorney's fees) arising out of or relating to a participant's participation in the Giveaway and/or accepting or using or misusing the FREE Product coupon.

The Giveaway Entities are not responsible for any malfunction of the Website, including if the Website tracker fails to end a Giveaway Window once the maximum number of Requests for the applicable Giveaway Window are submitted and received and in the event of such failure, Sponsor is not required to fulfill any FREE Product coupons that exceed the maximum to be given away as set forth in these Terms and Conditions. If the Giveaway is terminated before the designated end date, Sponsor will not be responsible to give away the full 62,500 FREE Products. By submitting a Request, each participant agrees that the Sponsor and/or Fulfillment Agency has the right to contact the participant via the email account provided by participant on the Request, when necessary, in order to administer and/or fulfill this Giveaway.

**11. Disputes/Governing Law.** Participants agree that: (i) any and all disputes, claims and causes of action arising out of or connected with this Giveaway, other than those concerning the administration of the Giveaway or the determination of FREE Product coupon recipients or for any disputes arising from the loss or injury from or in connection with receiving the FREE Product coupon, shall be resolved individually, without resort to any form of class action; (ii) any disputes arising out of these Official Rules (except for any disputes arising from the loss or injury from the use of FREE Product coupon) shall be submitted to final, binding arbitration conducted in Missouri under the Arbitration Rules and Procedures of the Judicial Arbitration and Mediation Services Inc. before a single, neutral arbitrator who is a former or retired Missouri state or federal court judge with experience in entertainment matters who shall follow Missouri law and the Federal Rules of Evidence and have no authority to award punitive damages.
