

**NESTLE PURINA PETCARE**  
**January 2026 - Spin to Win**  
**Official Rules**

**BY SPINNING, EACH ENTRANT AGREES TO THESE OFFICIAL RULES.**

1. **Eligibility:** The Nestlé Purina PetCare "January 2026 – Spin to Win" (the "Promotion") is open only to legal residents of the 50 United States and District of Columbia who are 18 years or older (or 19 if resident of AL or NE) and are members of the Purina loyalty program at the time of entry. THIS PROMOTION IS NOT OPEN TO THE GENERAL PUBLIC. Void where prohibited by law. No purchase necessary to enter the Promotion. The Promotion is subject to all applicable federal, state and local laws and regulations. Participation constitutes entrant's full and unconditional agreement to these Official Rules and Sponsor's decisions, which are final and binding in all matters related to the Promotion. Winning a prize is contingent upon fulfilling all requirements set forth herein.
2. **Promotion Period:** The Promotion starts at 10:00:01 AM Central Time ("CT") on January 13, 2026, and ends at 23:59:59 PM CT on January 31, 2026 ("Promotion Period").
3. **How to Enter.** To enter the Promotion, open your myPurina app (on Apple or Android) and log in using your Purina Rewards member log-in ("Rewards Account"). Once logged in, go to the Receipt Upload page, upload a receipt to receive one (1) spin. For Points offered in connection with a purchase, you must upload an image of a purchase receipt with legible retailer name, transaction date, identification of eligible Purina products purchased, and the price of Purina products. Each receipt can be used only one time, by one Account for up to 90 days after purchase. For each receipt uploaded during the promotion period, user will receive (1) spin. Points on spinner 'slice' will be automatically awarded to user's account within 48 hours. All spins must be completed by 23:59:59 PM CT on January 31, 2026, to be processed. 4. **Winner Selection and Notification:** Every participant who spins will win loyalty points that will be awarded to their account in the myPurina app. The odds of landing on any individual slice on the spinner is 1:8. The slice the spinner lands on is randomly determined with each spin. The points values on the slices are as follows: Four (4) slices: 25 points; One (1) slice: 50 points; One (1) slice: 75 points; One (1) slice: 100 points; One (1) slice: 150 points.

**Prize and Approximate Retail Values ("ARVs"):** Points awarded have no monetary value. Points have no cash value, are issued for promotional purposes only, are non-transferable, cannot be bartered, exchanged, or redeemed for cash, do not constitute your property, may not be combined with Points in other Accounts, and may not be transferred or assigned to any other person, entity, trust, or estate.

5. **Claiming the Prize:** No action is needed to claim prize once spin is completed. Points will be automatically awarded to loyalty member's account within 48 hours.

Sponsor reserves the right, in its sole discretion, to disqualify any individual it finds to be tampering with the participation process or the operation of the regulation
8. Promotion or to be acting in violation of these Official Rules or any other Promotion or in an unsportsmanlike or disruptive manner. Any attempt by any person to deliberately undermine the legitimate operation of the Promotion may be a violation of criminal and civil law, and, should such an attempt be made, Sponsor reserves the right to seek damages from any such person to the fullest extent permitted by law. Only the type and quantity of prize described in these Official Rules will be awarded. The invalidity or unenforceability of any provision of these rules shall not affect the validity or enforceability of any other provision. In the event that any provision is determined to be invalid or otherwise unenforceable or illegal, these rules shall otherwise remain in effect and shall be construed in accordance with their terms as if the invalid or illegal provision were not contained herein. Sponsor's failure to enforce any term of these Official Rules shall not constitute a waiver of that provision.

11. **Disputes/Governing Law:** Entrant agrees that: any and all disputes, claims and causes of action arising out of or connected with this Promotion, other than those concerning the administration of the Promotion or the determination of Winner or for any disputes arising from the loss or injury from the participation in a Prize, shall be resolved individually, without resort to any form of class action; (ii) any disputes arising out of these Official Rules (except for any disputes arising from the loss or injury from the use of Prizes) shall be submitted to final, binding arbitration conducted in Missouri under the Arbitration Rules and Procedures of the Judicial Arbitration and Mediation Services Inc. before a single, neutral arbitrator who is a former or retired Missouri state or federal court judge with experience in entertainment matters who shall follow Missouri law and the Federal Rules of Evidence and have no authority to award punitive damages. Either party may enforce a final arbitration award in any court of competent jurisdiction in Missouri including an award of costs, fees and expenses incurred in enforcing the award. Any dispute or portion thereof, or any claim for a particular form of relief (not otherwise precluded by any other provision of these Official Rules), that may not be arbitrated pursuant to applicable state or federal law may be heard only in a court of competent jurisdiction in Missouri; (iii) any and all claims, judgments and awards shall be limited to actual out-of-pocket costs incurred, including costs associated with entering this Promotion, but in no event attorneys' fees; and (iv) under no circumstances will entrant be permitted to obtain awards for, and entrant hereby waives all rights to claim punitive, incidental and consequential damages and any other damages, other than for actual out-of-pocket expenses, and any and all rights to have damages multiplied or otherwise increased.
