3. **How to Enter.** To enter the Sweepstakes, open your myPurina app (on Apple or Android) and log in using your Purina Rewards member log-in (“Rewards Account”). Once logged in, open the Rewards Catalog, then find and add the National Dog Show Busy Bee Sweepstakes Entry item to your Rewards Cart, and complete the checkout process to receive one (1) entry into the Sweepstakes random drawing. All entries must be submitted by 11:59:59 AM CT on December 1, 2025, to be eligible for the Sweepstakes random drawing. Sponsor is not responsible for any technical issue relating to the entry.
4. **Winner Selection and Notification:** Two thousand five hundred (2500) Grand Prize winners will be randomly selected from the pool of entries, to be conducted by Administrator on or around December 12, 2025 from among all eligible entries received. Each potential Grand Prize winner will be notified by Administrator or Sponsor, via email, to the email address associated with their Purina Rewards Account, on or about the day of the drawing. Each potential winner must respond within seventy-two (72) hours of the time the notification email is sent, or the prize will be forfeited and awarded to an alternate winner, time permitting.
