

**NESTLE PURINA PETCARE “PETIVITY CAT FEEDER + 1 YEAR OF FOOD” SWEEPSTAKES  
Official Rules**

- 1. - 3. How to Enter.** To enter the Sweepstakes, open your myPurina app (on Apple or Android) and log in using your Purina Rewards member log-in (“Rewards Account”). Once logged in, open the Rewards Catalog and add the Nestle Purina Pet Care “Petivity Cat Feeder” Sweepstakes Entry item to your Rewards Cart and complete the checkout process to receive one (1) entry into the Sweepstakes random drawing. You may enter one (1) time. All entries must be submitted by 11:59:59 PM CT on August 31, 2026 to be eligible for the Sweepstakes random drawing. Sponsor is not responsible for any technical issues relating to the entry.
- 4. Winner Selection and Notification:** One (1) winner will be randomly selected from all eligible entries, to be conducted by Administrator on or around September 8, 2026, from among all eligible entries received. The winner will be notified by Administrator or Sponsor via email to the email address associated with the potential winner's Rewards Account to be sent on or about the day of the random drawing (“Notification”).

Potential winners must respond via email, within **144 hours** from the Notification sent to their email address or prize will be forfeited and awarded to an alternate winner. Odds of winning depend on the total number of entries received.
