

**NESTLE PURINA PETCARE – PURINA ONE JULY 2026 SWEEPSTAKES**  
**Official Rules**

**NO PURCHASE OR PAYMENT NECESSARY. A PURCHASE WILL NOT IMPROVE YOUR CHANCES OF WINNING. VOID WHERE PROHIBITED BY LAW.**

**BY ENTERING THE SWEEPSTAKES EACH ENTRANT (OR THEIR PARENT/LEGAL GUARDIAN) AGREES TO THESE OFFICIAL RULES.**

1. **Eligibility:** The Nestlé Purina Petcare – Purina ONE July 2026 Sweepstakes (the "Sweepstakes") is open only to legal residents of the 50 United States and District of Columbia who are 18 years or older (or 19 if resident of AL or NE). Void where prohibited by law. No purchase necessary to enter the Sweepstakes. Employees of Nestlé Purina PetCare Company, 800 Chouteau Ave, St. Louis, Missouri, US 63102 (the "Sponsor"), Brandmovers, Inc., 1519 Carroll Dr. NW, Atlanta, GA 30318 ("Administrator") (collectively with Sponsor the "Released Parties"), and any of their respective affiliates, subsidiaries, advertising agencies, or any other company or individual involved with the design, production execution or distribution of the Sweepstakes and their immediate family (spouse, parents and step-parents, siblings and step-siblings, and children and step-children) and household members of each such employee are not eligible to enter or win. The Sweepstakes is subject to all applicable federal, state and local laws and regulations. Participation constitutes entrant's full and unconditional agreement to these Official Rules and Sponsor's decisions, which are final and binding in all matters related to the Sweepstakes. Winning a prize is contingent upon fulfilling all requirements set forth herein.
2. **Sweepstakes Period:** The Sweepstakes starts at 12:00:00 AM Central Time ("CT") on July 1, 2026, and ends at 11:59:59 PM CT on September 30, 2026 ("Sweepstakes Period").
3. **How to Enter.** To enter, download the free myPurina mobile app (the "App") available through the app store on your mobile device and register on the App. Once registered on the App, eligible entrants can log into the App using their Purina Rewards member log-in, open the Rewards Catalog to find and add the "Free Year of Purina ONE!" Sweepstakes Entry item to their Rewards Cart and complete the checkout process, including selecting from the drop down if you are entering for a chance to win a year supply of cat food, or a year's supply of dog food (each, a "Category"), to receive one (1) entry into that Category's random drawing. Limit one (1) App entry per person during the entire Sweepstakes Period. All App entries must be submitted by 11:59:59 PM CT on September 30, 2026, to be deemed an eligible entry.

Upon submitting the App entry, eligible entrants have a chance to earn up to one (1) additional bonus entry per Category (each, a "**Bonus Entry**") in one of the following ways:

4. **(1) Making a Qualifying Purchase:** To enter via this Bonus Entry method of entry, purchase any Purina ONE Dry Dog Food, or Purina ONE Dry Cat Food during the Sweepstakes Period (each, a "Qualifying Purchase"), and upload the receipt to the myPurina app. Upon completing receipt upload, user will be directed to submit a bonus entry in the reward catalog by adding the Bonus Entry Item to their reward catalog and completing the checkout process, including selecting from the drop down if you are entering for a chance to win a year supply of cat food, or a year's supply of dog food (each, a "Category"), to receive one (1) bonus entry into that Category's random drawing. Limit one (1) bonus entry per entrant, per category during the entire Sweepstakes Period. All bonus entries must be submitted by 11:59:59 PM CT on September 30, 2026, to be deemed an eligible entry.

**OR (2) Email Entry:** To enter via this Bonus Entry method without making a Qualifying Purchase, eligible entrants can send an email via the contact form at [www.purina.com/contact-us](http://www.purina.com/contact-us) with

their first and last name, street address, city, state, zip code, and telephone number, along with the Category (i.e., either "Cat" or "Dog") they wish to enter in the body of the email and using "Purina ONE July 2026 Sweepstakes" in the Subject line of the email. Limit of one (1) Bonus Entry per entrant per Category, during the entire Sweepstakes Period, regardless of the method of entry. All Bonus Entries must be submitted by 11:59:59 PM CT on September 30, 2026, to be deemed an eligible entry.

Sponsor is not responsible for any technical glitches associated with the entry process.

5. **Winner Selection and Notification:** One (1) Grand Prize winner per Category (for a total of two (2) Grand Prize winners) will be selected via a random drawing to be held by Administrator on or about October 2, 2026. The potential winners will be notified by Administrator via email notifying the individual they are a potential winner, to be sent to the email address associated with the potential winner's App registration on or about the day of the random drawing (each a "Winner Notification"). The potential winners must respond within **72 hours** from Administrator sending the Winner Notification email to the potential winner in order for Administrator to verify the potential winner's contact information and eligibility. In the event a potential winner fails to respond to the Winner Notification within **72 hours**, that potential winner forfeits their right to be a Grand Prize winner and their right to receive the Grand Prize, and an alternate winner will be selected, time permitting, at Sponsor's sole discretion. Neither Administrator nor Sponsor are responsible for any undeliverable, misdirected, unanswered or technical glitches associated with the Winner Notification email being sent or received. Odds of winning depend on the total number of entries received during the Sweepstakes Period.
6. **Prizes and Approximate Retail Values ("ARVs") – Two (2) Grand Prize (one (1) per Category) –** A one (1) year supply of EITHER Purina ONE Dry Dog Food, OR Purina ONE Dry Cat Food (depending on the Category the winner is selected from), to be awarded in the form of twelve (12) coupons. ARV: \$875.88 for dog, \$791.88 for cat. The coupons are subject to the terms, conditions and restrictions printed on the coupon. The total ARV of all Prizes is \$1,667.76

7. **Claiming the Prize:** Upon Administrator's receipt of the response to the Winner Notification, Administrator or Sponsor will mail the Grand Prize to the winner, to the address provided by the winner during the Winner Notification process. Neither Administrator nor Sponsor are responsible for any lost, late, stolen, misdirected, mutilated, or any other problems associated with the mailing of the Grand Prize to any winner. Allow 4 to 6 weeks for the mailing of the Grand Prize.
8. **Participation Conditions/Release/Consent to use Likeness:** By participating, each participant agrees to: (a) comply with and be bound by these Official Rules and the decisions of the Sponsor which are binding and final in all matters relating to this Sweepstakes; (b) release and hold harmless the Released Parties from and against any and all claims, expenses, and liability, including, but not limited to, negligence and damages of any kind to persons and property, including, but not limited to, invasion of privacy (under appropriation, intrusion, public disclosure of private facts, false light in the public eye or other legal theory), defamation, slander, libel, violation of right of publicity, infringement of trademark, copyright or other intellectual property rights, property damage, or death or personal injury arising out of or relating to a participant's participation in this Sweepstakes, and acceptance or use or misuse of prize; (c) indemnify, defend and hold harmless the Released Parties from and against any and all claims, expenses, and liabilities (including reasonable attorney's fees) arising out of or

relating to an entrant's participation in the Sweepstakes and/or entrant's acceptance, use or misuse of prize; and (d) allow Sponsor's use for promotional purposes of his/her likeness, voice and/or address (city/state) without any additional compensation.

9. **General Conditions:** Sponsor reserves the right to cancel, suspend and/or modify the Sweepstakes, or any part of it, for any reason whatsoever, including, without limitation, fire, flood, natural or man-made pandemic or epidemic of health or other means, earthquake, explosion, labor dispute or strike, act of God or public enemy, satellite or equipment failure, riot or civil disturbance, terrorist threat or activity, war (declared or undeclared) or any federal state or local government law, order, or regulation, public health crisis, order of any court or jurisdiction or if any fraud, technical failures or any other factor beyond Sponsor's reasonable control impairs the integrity or proper functioning of the Sweepstakes, as determined by Sponsor in its sole discretion. Sponsor reserves the right, in its sole discretion, to disqualify any individual it finds to be tampering with the participation process or the operation of the Sweepstakes or to be acting in violation of these Official Rules or any other Sweepstakes or in an unsportsmanlike or disruptive manner. Any attempt by any person to deliberately undermine the legitimate operation of the Sweepstakes may be a violation of criminal and civil law, and, should such an attempt be made, Sponsor reserves the right to seek damages from any such person to the fullest extent permitted by law. The invalidity or unenforceability of any provision of these rules shall not affect the validity or enforceability of any other provision. Sponsor's failure to enforce any term of these Official Rules shall not constitute a waiver of that provision.

12. **Disputes/Governing Law:** Entrant agrees that: (i) any and all disputes, claims and causes of action arising out of or connected with this Sweepstakes, other than those concerning the administration of the Sweepstakes or the determination of Winner or for any disputes arising from the loss or injury from the participation in a Prize, shall be resolved individually, without resort to any form of class action; (ii) any disputes arising out of these Official Rules (except for any disputes arising from the loss or injury from the use of Prize) shall be submitted to final, binding arbitration conducted in Missouri under the Arbitration Rules and Procedures of the Judicial Arbitration and Mediation Services Inc. before a single, neutral arbitrator who is a former or retired Missouri state or federal court judge with experience in entertainment matters who shall follow Missouri law and the Federal Rules of Evidence and have no authority to

award punitive damages. Either party may enforce a final arbitration award in any court of competent jurisdiction in Missouri, including an award of costs, fees and expenses incurred in enforcing the award. Notwithstanding the foregoing, Released Parties shall be entitled to seek injunctive relief (unless otherwise precluded by any other provision of these Official Rules) in the state and federal courts of Missouri. Any dispute or portion thereof, or any claim for a particular form of relief (not otherwise precluded by any other provision of these Official Rules), that may not be arbitrated pursuant to applicable state or federal law may be heard only in a court of competent jurisdiction in Missouri; (iii) any and all claims, judgments and awards shall be limited to actual out-of-pocket costs incurred, including costs associated with entering this Sweepstakes, but in no event attorneys' fees; and (iv) under no circumstances will entrant be permitted to obtain awards for, and entrant hereby waives all rights to claim punitive, incidental and consequential damages and any other damages, other than for actual out-of-pocket expenses, and any and all rights to have damages multiplied or otherwise increased.
