

Free Year of Tidy Cats Performance Plus Sweepstakes

2. **How to Enter.**

You may earn Entries by completing any of the activities listed below.

Open your myPurina app (on Apple or Android) and log in using your Purina Rewards member log-in ("Rewards Account"). Once logged in, open the Rewards Catalog and add the Free Year of Tidy Cats Performance Plus Sweepstakes Entry item to your Rewards Cart, and complete the checkout process to receive one (1) entry into the Sweepstakes random drawing. Alternatively, you may email customer service at www.purina.com/contactus and provide your full name, address, and the email associated with your Purina rewards account to receive one (1) entry into the Sweepstakes.

To receive 100 additional entries, open your myPurina app, log in using your Rewards Account. Once logged in, open the Rewards Catalog and add the 100 entries into the Free Year of Tidy Cats Performance Plus Sweepstakes item to your Rewards Cart, and complete the checkout process by redeeming two hundred fifty (250) points from your Rewards Account to receive one hundred (100) additional entries into the Sweepstakes random drawing. Points will be deducted from your Rewards Account on or before May 1, 2026. Must have 250 or more points in your Rewards Account on the date points are deducted to receive one hundred (100) additional entries via this method of entry.
