page, upload a receipt to receive one (1) spin. For Points offered in connection with a purchase, you must upload an image of a purchase receipt with legible retailer name, transaction date, identification of eligible Purina products purchased, and item transaction amount. Each receipt can be used only one time, by one Account for up to one month after purchase. For each receipt uploaded during the promotion period, user will receive (1) spin. Points on spinner 'slice' will be automatically awarded to user's account within 48 hours. All spins must be completed by 11:59:59 PM CT on May 31, 2025, to be processed. The slice the spinner lands on is randomly determined with each spin.
